Notes for contributors

Unless agreed otherwise all accepted papers become the copyright of the Learning Teacher Network. All contributors should be aware that they are addressing an international audience.

Four complete copies of the manuscripts should be sent, or preferably e-mailed, to the Editor, Bill Goddard, The Learning Teacher Journal, University of Greenwich, Avery Hill Campus, Bexley Road, Eltham, London, SE9 2PQ, UK. (w.d.Goddard@gre.ac.uk)

Manuscripts submitted should be original, not under review by any other publication and not published elsewhere.

All pages should be numbered. Footnotes in the text should be avoided. Sponsorship of research reported should be declared. To allow for refereeing all submissions should be properly formatted for anonymous reviewing. Authors' names and institutions should be typed on a separate sheet and submitted with the manuscript. The full postal and e-mail address of the author who will check proofs and receive correspondence should be included.

The main text should be between 5,000 and 7,000 words in length. Each paper should be accompanied on a separate sheet by an abstract of 100 to 150 words.

References should be indicated in the typescript by giving the author's name, with the year of publication in parentheses. If several papers by the same author and from the same year are cited, a, b, c, etc. should be put after the year of publication. The references should be listed in full, including pages, at the end of the paper in the following standard form:

Titles of journals and names of publishers, etc. should not be abbreviated. Acronyms for the names of organisations, examinations, etc. should be preceded by the title in full.
